The main purpose of this visit was to discuss the recent complaints odour from the Rassau Installation and dust from the Tafarnaubach Facility

We discussed both complaints and in particular the regular complaints regarding Industrial Odour smell from this installation. Investigations to date by NRW and Envirowales have not been able to substantiate this odour. All CEMS and lead monitoring on site and at the Sensitive receptor has no highlighted and elevated emission value. During this inspection it was decided to visit the area of the complainant and undertake olfactory monitoring (Dave Griffiths – NRW, Brian Kelly and Terrie Williams – Envirowales) - This investigation in the Brynmawr area did not detect any odours.

Subsequently NRW have requested our air quality team to review the modelling plume from site to ensure that there is no environmental impact from this installation on this community

We discussed the recent draft IED Permit – Envirowales to Review and provide feedback w/c 7th August 2018

Although not covered by this Permit we discussed the Slag recycling facility and the recent dust complaints and health concerns. NRW have discussed health concerns with a company / business in the vicinity of Unit 5 and have hopefully addressed their concerns. However, an orange in colour residue / dust is still ongoing, although at this time we do not believe that this has anything to do with the operations at Envirowales we recommend that a sample of this orange residue is taken for reference purposes and analysed – Envirowales have agreed to action this.

Envirowales provided an update on site activities that included new kettles and workshop construction. Envirowales requested an update on the abstraction borehole consent – NRW to follow up
