### Routine Site Inspection with Brian Kelly – EHS Director

- Discussed the proposed engineering works for relocating the furnace slag handling facility from Unit 5 Tafarnaubach to Rassau Industrial Estate. Plans still in progress for the relocation and proposed building designs and layouts was discussed. The current plan is to increase the storage capacity of processed slag to 3000 tonnes. This will enable the company to transport the slag for recovery by Cargo ship rather than mostly by road to Norway. This will undoubtedly reduce the company's carbon footprint by reducing the number of lorry movement and road miles currently being undertaken.
- Envirowales confirmed that the current slag handling process located on Tarfarnaubach Industrial Estate is currently having a deep clean along with the adjacent building. Furthermore, engineers have been on site to check building integrity and a negative pressure test has been undertaken. – Minor repairs have taken place. There will be regular checks by management until the relocation of this process takes place.
- Discussed recent COMAH visit with some concerns raised over NRW role and informal discussion were undertaken with NRW COMAH Lead.
- Since this inspection on the 15<sup>th</sup> January <sup>2018 CP</sup> ~~2017~~ at approximately 5pm NRW received a complaint from a local resident in Brynmawr regarding a Strawberry Blancmange odour. Investigations were undertaken by Envirowales and NRW and concluded that this odour is not associated with the activities at this installation. NRW have provided feedback to the complainant and discussed the odour with the Local Authority.
