Routine site inspection with Brian Kelly - EHS Director

- Main focus of this inspection to discuss and assess the recent odour complaints that have been reported to NRW.
- Recent odour investigations have not associated the site with the complaints received. All CEMS data has been within ELV's and olfactory monitoring has not proven any link to the installation.
- Envirowales are now continuously undertaken olfactory monitoring around the site and provided evidence to NRW of the investigations to date. The assessments have indicated other sources odour in the locality. Envirowales will continue to review this situation.
- Discussed Groundwater abstraction application and the process of obtaining consent - NRW agreed to provide further information on this process. NRW have completed this action.
- Discussed the recent Reg 60 Notice for the IED Permit review - Non Ferrous Sector - NRW provided a brief update, however a more detailed response will be provided.
