The annual reporting forms were received on 26th January 2015. They refer to the calendar year 2014, whereas International Rectifier Newport (IRN) measure their own targets against their financial year which runs from 1st July to 30th June. Comments given below may therefore differ from those in IRN internal reports for their financial year, due to the different time periods.

All the reports are satisfactory and are accepted.

Form S1: Emissions to Sewer, 1st July to 31st December 2014

All emissions were less than their respective ELVs.

Form E1: Energy Usage for 2014

Primary energy usage and thus CO₂ production were less than in 2013 and are the lowest since 2006, despite an increase in production volumes. Primary energy use fell by 4% and CO₂ production by more than 12%.

Form WU1: Water Usage for 2014

Again a significant reduction of almost 11% compared with 2013 and the lowest since 2005.

Form R1: Waste Disposal and Recovery for 2014

Solvent waste increased by 20%.

Hazardous wastes sent to landfill were 30% less than in 2013. Those sent for recovery increased by 22% compared with 2013.

Non-hazardous wastes sent to landfill were 16% less than in 2013 and the amount sent for recovery increased by 5%.

These are encouraging results. The Waste Strategy encourages operators to reduce the amount of waste sent to landfill and to increase recycling and recovery rates. IRN have shown that they are committed to this philosophy and should be commended for their achievements.

Silicon output for 2014

This has increased by 10% compared with 2013, without a corresponding increase in resources.

4.1.4 Fugitive Emissions

Due to changes in production less solvent is collected in tanks that may vent to atmosphere, reducing the likelihood of fugitive emissions. IRN now calculate these to be less than 5% of the total volume of solvent used.

4.1.5 Progress against EMS targets for FY 2014

All the targets set have been achieved. Energy and water consumption have been reduced and the dry waste recycling rate maintained.

IRN have demonstrated their continuing commitment to reducing their resource consumption and waste production. There has been a significant increase in production volumes this year without a corresponding increase in resource consumption and waste production. IRN are to be congratulated on their determination to minimise their impact on the environment while maintaining a healthy business.
