The purpose of this visit was twofold; for Natural Resources Wales (NRW) compliance officers to learn more about the manufacturing process carried out by International Rectifier Newport (IRN) and to review the Site Closure Plan (SCP), with particular reference to Fab 10.

After a brief review of future plans for the site, Rebecca Green (RVG) and David Willey (DW) were given a most informative tour of the wafer manufacturing and test facilities by the Environmental Engineer.

The SCP was discussed and RVG recommended that it be reviewed and updated. In view of the decommissioning of Fab 10, IRN were advised to record any incidents that had occurred since December 2005 (when the EPR permit started), their outcomes and any resulting actions. IRN should also review the Site Protection and Monitoring Plan to check whether further ground contamination testing is necessary.

IRN are also reminded that their annual review of the site's OPRA score is due by the end of 2016.

For any decommissioning activities IRN need to ensure that all necessary procedures are in place and up to date; that responsible persons are clearly identified and understand their duties; that the competency of any contractors employed is confirmed and recorded and that any waste generated is disposed of in an appropriate manner with full traceability.

Once the area is fully decommissioned IRN should inform NRW, who will arrange a site visit. Once agreed that the arrangements are satisfactory IRN should notify NRW by letter, to include photographic and documentary evidence as appropriate. NRW will formally confirm that the arrangements are satisfactory via a CAR form. The same procedure can be used when emission points are taken out of use.

Monitoring of air emissions was discussed. Since there are no permit requirements to monitor air emissions, it is entirely IRN's decision as to whether emissions are monitored.
