Audit Action 1: Send bund drawings and/or construction specifications to NRW.

Drawings were received by NRW on 9th December 2014. The bunds were constructed to the relevant British Standard applicable in 1996. The concrete is reinforced and the bund walls contain waterstops.

Action 1 is accepted as complete.
