The effluent treatment trial ended on 12th June 2015. International Rectifier (IRN) called a meeting with Welsh Water (WW) and Natural Resources Wales (NRW) to review the results.

Samples of the discharge to sewer had been taken twice daily by Omex and analysed in their laboratories. WW also took two regular monitoring samples while the trial was running.

All the results from samples taken and analysed by Ormex were within IRN's discharge consent limits and except for suspended solids and chemical oxygen demand (COD) were within the normal range of results for IRN. These results did not, however, agree with those from the samples taken by WW. These showed an unusually high COD and suspended solids on 18th May, although both were within the discharge limits. Samples taken by WW on 27th May showed an unusually high value for suspended solids (183mg/L), which was atypical of all the other results obtained during the trial. This anomaly was probably due to cleaning of the trial equipment prior to its being returned to Ormex because the trial had finished. As yet there are no results from Omex to compare with these.

Overall, IRN have deemed the trial to be a success, but the process will have to meet IRN's strict financial criteria before it can be installed as a replacement for the present treatment process.
