International Rectifier (IRN) have started running the trial described in CAR BV7460ID/0236092. Natural Resources Wales (NRW) and Welsh Water (WW) were invited to inspect the trial.

The company who supply the magnesium hydroxide, $Mg(OH)_2$, gave a short presentation describing the material, its benefits and laboratory results obtained with samples of IRN's raw effluent. The initial laboratory results suggested that less $Mg(OH)_2$ would be needed for pH adjustment than sodium hydroxide and that the volume of resulting sludge would also be reduced.

The $Mg(OH)_2$ was stored in a small road tanker equipped with several stirrers to keep the material in suspension. It resembles thick grey cream. The material was pumped from the tanker to the dosing unit, housed in a small, covered trailer, which also contained some monitoring equipment and from there it was pumped to the effluent treatment tanks. Containment for all vulnerable parts of the equipment was more than adequate.

The trial and its results will be most interesting and NRW would like to thank IRN for their hospitality in inviting us to see it in operation.
