International Rectifier Newport (IRN) have sought permission from Natural Resources Wales (NRW) under condition 1.5 of their EPR permit to conduct a trial on an alternative way of treating the aqueous effluent from their semi-conductor manufacturing process.

The effluent has a low pH which is adjusted to between 6 and 11 with sodium hydroxide, NaOH, before discharge to the foul sewer under a consent from Welsh Water.

The proposed change involves replacing the NaOH with magnesium hydroxide, Mg(OH)₂. This will have a number of health and safety and environmental benefits if successful.

The Mg(OH)₂ will be held in a double-skinned road tanker adjacent to the effluent treatment area. The control panel and pumps will be housed in a covered trailer in the same area. The trial is designed to run for two weeks.

Containment will be deployed where connections and receptacles are outside of existing bunds. IRN personnel will be trained in specific emergency procedures for the trial equipment and IRN's normal incident procedure will apply in the event of any incident or accident.

Welsh Water and NRW have been invited to inspect the trial once it is running.

Welsh Water have also been consulted about this trial and have no objection to its going ahead.

NRW are pleased to give their permission for IRN to proceed with the trial replacement of NaOH with Mg(OH)₂ for pH adjustment of their aqueous effluent before discharge to foul sewer.
