The Fugitive Emissions Review Report was received on 27th February 2018. It is a full and comprehensive review of all possible sources of fugitive emissions.

Newport Wafer Fab (NWF) do not emit any dusts and VOC emissions are monitored in line with permit requirements.

There are some unavoidable fugitive solvent emissions, but these are minimised as far as is possible. Due to the nature of production in 2017, overall solvent use increased and therefore there will have been a small increase in fugitive emissions. This is not considered significant and therefore does not warrant controls beyond those that are already in existence.
