Background information

On the 18/07/15, the site was attended out of hours by standby officer Martyn Davies due to a report of a fire on site. The fire was confirmed by the officer who observed waste wood including non-virgin wood.

On investigating this further, it is now clear in discussions with the officer that the fire occurred within the site boundary and is therefore a non-compliance with the Permit conditions and has been marked as such on this CAR inspection form.

This fire was also not in accordance with the U4 exemption which was previously held on the site - you should be aware that this U4 exemption registered (ref AH0769WJ) expired on 31/07/14. If you wish to continue using your incinerator on site, you must re-register this as soon as possible.

Breaches

Two breaches have been noted against the permit:

1)
A1 - Category 3 breach against permit condition 2.1.1
This condition specifies the activities that are permitted on site, burning waste is not permitted as a treatment or disposal activity.

2)
C2 - Category 3 breach against permit condition 1.1.1
This condition specifies that the site must operate in line with your own Environmental Management System which states in section 5.11 "No material of any kind shall be burned within the boundaries of the site"

Actions

You must ensure you do not allow any further fires to occur on site as stated in your EMS and Permit condition. Please be aware that we are now considering whether further action will be taken and will contact you in due course.
