Introduction

Site inspection by Geraint Richards, the new regulator for this Permitted operation and Jacqui Collier. The weather was dry, and we met Simon and Carl on site who accompanied us on the inspection.

Observations

The two main activities on site were inspected - the non-haz transfer station and inert materials processing.

All activities are carried out within the site boundary and appear in line with the requirements of the Permit. We inspected the drainage system, which appeared to be in order and no standing water was observed on site.

The site was in operation at the time of inspection, with good separation of the various activities. It was noted that waste was being sorted into piles of inert and other materials in line with the Management System. The Permit allows a maximum throughput of 75 000 tonnes per year and there is no indication at this time that this is being exceeded. Stockpiled materials on site also appeared to be manageable at the time of visit.

Inert materials are processed according to the Aggregates Quality Protocol (WRAP) for sale to customers and storage of these is according to grade and specification.

Non-haz waste material appeared to consist of mainly construction and demolition waste from builders and similar and was being processed through a picking line and trommel.

I did not observe any problems with vermin or nuisance and in general the site appeared to be managed well although litter may become a problem in high winds.
