A desk based audit has been carried out to check for completion of the new waste returns spreadsheet and to raise any issues noted within the form. You have correctly submitted returns including the latest one for Q1 (Jan-Mar) 2015, thank you for sending these in.

The amount of waste leaving the site is significantly lower than that received however I'm aware of the work you carry out at the site in producing non-waste aggregates from the inert materials imported to site under the Quality Protocol for aggregates production.

No breaches have been scored against this audit as the purpose is very much a fact finding and advice giving process. The points made are not aiming to question on site processes on site but just to confirm the correct Recovery / Disposal Codes are being used for the destination site against the waste codes provided.
