Met with Carl Davies on site.

Picking line was in use. James Williams commented that this was the first time he had seen this. It was queried where the fines from the picking line are going and we were advised they are taken to Trecatti.

Site was wet and muddy at the time of our visit with standing water around waste storage areas.

There are two oil storage tanks to the rear of the workshop which are in a brick bund. It is advisable that bunded areas constructed of brick or masonry blocks are also rendered for better protection in the event of a spill.

We received a report of burning taking place on site on 08 February 2014. This was queried and Carl confirmed that the fuel burner in the workshop had been in use. U4 exemption registered to site ref AH0769WJ valid until 31-07-14.

Weather conditions at time of visit – dry and cold following period of heavy rainfall.
