### **E.T Davies Site Visit – Penrhiwfer (SP3395FU) – 18/10/2018**

Environment officer Craig Coleman attended E.T Davies end of life depollution facility in Penrhiwfer, Rhondda Cynon Taff; on 18/10/2018 and met with Virgil Davies. A routine site inspection was conducted assessing the condition of the facility, the amount of ELV's and tyres stored on site and general infrastructure of the site.

**(A1) Specified by permit** The permit dictates that only 250 vehicle bodies and 100 waste tyres may be maintained on site at any given time. The site was under this limit at the time of the visit.

### **(B4) Containment of stored materials**

All fluid drained from depolluted vehicles is kept within the correct storage types. Batteries are stored in a battery box until disposed of and all ELV's waiting to be depolluted were on the concreted area within the covered depolluting bay.

### **(C2) Materials Acceptance**

All of the waste held on site was within E.T Davies' permit remit and within the specified limits.

### **(D1) Security**

The site is well secured with an 2m boundary fence, the site also has a guard dog that patrols the premises at night.

### **(E2) Emissions – Land**

All of the vehicles are depolluted on an impermeable concrete surface. Cars once depolluted are stored up on a gravelled hard standing with no signs of pollutants entering the ground.

### **Other comments**

The site was in a good clean condition on the day of the inspection, none of the ELV's which are maintained for recovery of part for sale were stored in a dangerous manner or in such a way that would cause an impact to the environment.
