Annual reporting

Forms received:

- A1 - received on 6th May 2015
- P1 - received on 28th July 2015

Both forms were late, and as such a non compliance (Category 4) has been recorded. It is important that Welsh Water ensure that staff are aware of their roles and responsibilities with regard to the requirements of the permit.

Form A1 contains exceedances for Carbon Monoxide at emission points A1 and A2. In view of this a non compliance has been recorded (Category 3). I understand that a rebuild of the engines should prevent further exceedances.

Incidents of 6th July and 17th July

Schedule 6 reports received on 12th July and 28th July respectively.

There were two incidents reported where potentially odourous steam was vented. One incident coincided with a complaint of odour from nearby premises on 6th July 2015.

Given the potential impact, we have recorded a non-compliance (Category 3) for the event where odour was reported. NRW intends to visit the CHP / AD facility to investigate the route cause of the steam releases, and to ascertain whether improvements are needed to prevent further releases.

The Schedule 6 reports were also submitted late. The permit requires that notifications of malfunction should be reported immediately and followed up with a Schedule 6 form within 24 hours. As a non compliance for the other late reports has already been recorded above, I have not recorded a further non compliance.
