4. Details of our assessment

A site inspection was conducted by Sally Wakeford on 10 November 2021, accompanied

on site by Stuart Hanford.

The site appeared well organised and to have good segregation of materials.

The stockpile of fines from the washplant appeared to be well managed.

During the inspection it was noted that a load of waste had been deposited which was quite contaminated. Loads like this would typically have been diverted to the RRF, however in this instance this didn't happen. Stuart confirmed that this load would be removed to the RRF for sorting. Please ensure all staff are aware of the procedure for dealing with non-conforming loads.

The site boundary appears to be creeping closer to the rivers edge. The site boundary does not go all the way to the riverbank, and a buffer zone should be created to ensure no waste escapes the site and enters the river. It could not be confirmed at the time of the inspection if the waste was inside or outside the permit boundary.

Whilst on site we discussed the procedures NRW would expect to see for meeting end of waste on a case by case assessment. This information will be provided via email under a separate cover.
