NRW note that you have removed the passive skimmer.

NRW also note that you have investigated the discolouration of the groundwater around BH6S and we agree with the additional sampling suggested up and down gradient at BH11 and MW2.

NRW request that you include BH4 and BH6 as cross gradient boreholes to get the lateral extent of the potential contamination – we have a recollection that BH4 and BH5 to the west of BH6S also was coloured black at one point due to the hydrocarbon plume.

Furthermore, another reason for the discolouration could be the borehole construction failing are you able to investigate with geophysics?
