Production on site will begin manufacturing aluminium car chassis in September on a shift pattern

Discussed operational issues and delivery times in order to minimise fugitive emissions such as noise that has previously been an issue. SAPA to review new site procedures, EMS, staff training and provide updates where relevant to NRW.

Site walk around confirming no more extrusion and dye casting. Site activates now include anodising and fabrication. Permit review by NRW and SAPA to ensure all current activities are currently permitted.
