NRW have assessed the above report, we have made the following observations / comments:

We acknowledge you have investigated the discolouration of the groundwater from BH6S and the surrounding monitoring points. You have identified elevated iron in BH6S itself and high TSS in other boreholes. There is not much details on likely causes of this, but at least we know that it is not hydrocarbon.

We note that you have removed the passive skimmer, but ironically that free phase was then observed.

We also need to establish when you are planning on starting operation at the anodising plant. We previously suggest reducing the sampling frequency, but if you are going to start limited operation again at the site then we suggest the 6 monthly sampling.
