Further to the above submission, our Geoscience team have reviewed your report with the following comments.

NRW note that the passive skimmer was removed from BH12 in August 2016 – this had been installed to collect free phase product in small volumes – ironically free phase product was identified in this borehole with a thickness of 20mm, we will just review this during next round of monitoring. If the free phase product returns, then the passive skimmer might need to be reinstalled.

The trigger level at BS06 for hydrocarbon has been exceeded – this had been set to be protective of the Rhymney river downgradient from the site. The exceedance is only minor, but if it is exceeded during the next round then we might need to investigate further.

There are few results that are elevated from previous round and marginally exceed EQS – this is mainly due to the natural seasonal variation of groundwater – but again we will review this during the next round of monitoring.
