Annual Oil Treatment Data for 2013

The data was received on 5th February 2014. A total of 166.02m³ of oil was recovered and sent off site for treatment. This is 3.8% less than in 2012.

Form Ambient Air, 1st July 2013 to 31st December 2013, was received on 27th January 2014. All the reported VOC concentrations were well below the ELV of 75mg/m³. Average VOC concentrations in the ambient air around the site in 2013 were 0.85mg/m³, well below the ELV of 75mg/m³.

Action: Monitoring of ambient air, as described in Permit Condition 3.3.1 and the associated reporting requirements given in Permit Conditions 4.2.2 (a), 4.2.2 (c) and 4.2.3, is thus no longer considered necessary by Natural Resources Wales and **may cease from 1st January 2014 until further notice.**
