The waste produced on site in 2016 has reduced per tonne of product from previous years.

WU1 Form

The water used per tonne of product increased slightly in 2016.

E1 Form

The energy used per tonne of product has remained fairly consistent with previous years.

Maintenance Schedule

The site now has a written planned maintenance schedule, which includes a list of environmentally critical equipment. This will be assessed in detail during future site visits.

The molasses tank is due to be replaced by the end of June 2017.

IBC Bund

A bund has been installed to store ibc's in. These will be fully assessed during future site visits. The Operator shall ensure that procedures are in place for the correct disposal of any liquids that are captured in the bund.

EP OPRA Review

The Operator has reviewed their EP OPRA score and the updated information has been placed on the NRW system.

Training Assessment

A training needs analysis has been carried out for all roles on site. This identifies which training is required for each role, when it was taken and when it is due again. The detail will be assessed further during future site visits.

Permit Requirements

Permit condition 2.11.2 requires that a full review of the site's closure plan is carried out at least every four years. Please can you confirm when this was last completed
