1. Permit condition (pc) 2.11.2, Site closure plan – received 13 Sep 14. Accepted in full.
2. Q3 returns, Jul, Aug, Sept 2014 – received 2 Oct 2014, within permit required deadline of 28 days of the end of the reporting period, accepted in full.
3. Q4 returns, Oct, Nov, Dec 2014 – received 15 Jan 2015, , within permit required deadline of 28 days of the end of the reporting period, accepted in full.
4. Annual Returns W1, R1, WU1, E1, PI1 received 23 Jan 2015, , within permit required deadline, accepted in full.
5. Pollution Inventory return (P.I.) – submitted 27 Feb 2015, within the reporting deadline, accepted in full.
6. Q1 returns, Jan. Feb, Mar 2015 – received 10 Apr 2015, before the permit deadline. Note, the suspended solids reading were within the permitted maximum, but the reading represents a huge increase in historical returns. Site is urged to be mindful of this approach to the limit. (56 mg/l against a maximum 60mg/l with an uncertainty of 9.8% for Jan 15).
