A noise complaint was received by the Operator on 1 October 2015.

Prior to the complaint the Operator had been made aware that there was an issue with the ice machine. The machine was blocked and was causing a noise. The machine was subsequently turned off. However, the requirement for notification of the issue to Natural Resources Wales was not considered by the Operator.

CCS breach 3 for failing to notify as per section 5 of the permit.

Condition 2.3.2 of your permit requires that the installation is supervised by staff who are suitably trained and fully conversant with the requirements of the Permit. Relevant personnel shall be made aware of the permit requirements. This is linked into the improvements being carried out to the site Environmental Management System and should be carried out by the end of November 2015.
