Complaints relating to refrigerant trailers running on diesel rather than electric on 4 and 5 September 2015.

The Operator has confirmed that the electricity supply was upgraded and in place by the end of August. However, the Supervisor on shift at these times did not utilise the electric hook ups.

Procedure "04 Noise" has been provided to Natural Resources Wales. The procedure was updated on the 1 September 2015, and training given to all relevant staff on 2 September. However, the procedure is not robust enough to secure compliance with the permit conditions relating to noise. For instance - It does not stipulate that the refrigerant trailers should be hooked up to electric at all times they are parked up.

A number of permit conditions have been breached as a result of this issue.

### **2.9.1 - The Operator shall use BAT so as to prevent noise**

Leaving vehicles running on diesel is not considered BAT. The Operator was given until end August to resolve this issue, which they completed. However, vehicles have been left to run on diesel since this date. The Operator is aware of the off site impact of running the refrigerant vehicles off diesel.

### **1.3.1 - The Operator shall implement and maintain an EMS sufficient to achieve compliance with the Permit.**

The procedure relating to noise is not adequate to secure compliance with the permit conditions.

The Operator previously stated that their EMS review and implementation would be complete by end July 2015. An audit will take place in the coming months to assess the adequacy of the rest of the EMS.
