4. Details of our assessment

Subsequent to previous Schedule 5 Notifications and NRW's response (CAR 38692) Solutia submitted further Schedule 5s related to repeated issues affecting the site effluent pipeline, these are summarised below:

Part A 9th September 2021 and Part B 3rd December 2021

- Pipeline leak in the inter-tidal area, repairs completed, unable to determine quantity of effluent released prior to the normal point of release.

Part A 30th September 2021 and Part B 3rd December 2021

- Need to discharge during the normal 'cease discharge' period due to ongoing pipeline repairs that coincided with periods of heavy rain. These periods were not of extended duration, occurred on four dates and involved effluent that was within the discharge consent limits.

Solutia are planning replacement/relining of the discharge pipeline from the point of discharge to the estuary back to the non-return valve, as a response to the known issues and potential for more serious failure in the future. The pipeline was originally installed in 1960. This is a good response. The minor leaks that have been identified to date are not considered to be of any environmental consequence on the basis that the volumes released are estimated to be minor, repairs have been completed as soon as possible and the effluent was within the permitted discharge limits.

On this basis, no non-compliances have been recorded.

Solutia are sharing plans for the pipeline replacement project and engaging with NRW to help ensure all necessary permissions for the works are in place before commencement.
