Permit condition 2.9.1 says that "*The Operator shall use BAT so as to prevent or where that is not practicable to reduce emissions of noise and vibration from the Permitted Installation, in particular by:*

- *equipment maintenance*
- *use and maintenance of appropriate attenuation*
- *timing and location of noisy activities and vehicle movements*
- *periodic checks of noise emissions*
- *maintenance of building fabric*

A noise complaint was investigated by Randall Parker Foods on 2 June 2016 and the cause of the complaint found to be as a result of general waste being moved around site to the compactor, in the early hours of the morning.

This activity should only be carried out during normal working hours. Breach of permit condition 2.9.1

The Operator should review the procedures in the existing management system to ensure that they are adequate to secure compliance with the permit. The training of night time staff should also be reviewed to ensure it is adequate and that all relevant staff understand the implications of their actions on permit compliance.
