4. Details of our assessment

The site inspection was conducted on Wednesday the 17th of November by Natural Resources Wales officers Cathrine Kiely (Senior officer, Waste Regulation) and Donna Muirhead (Officer, Waste Regulation) and also present was Lee Jones (site TCM/director).

The inspection was carried out following an inspection at the neighbouring adjoining permitted site World care (Wales) Ltd, permit ref UP3794FZ.

The weather at the time of the inspection was dry and cloudy although the ground underfoot was wet and muddy.

Although the site was open during the time of the visit there was no waste activity going on. All materials stored on site were permitted wastes as stated on the permit.

Non compliances

F5 Deposits on the road. Permit condition 1.1.1 General Management. Compliance Classification Scheme Category 3 breach

The highway and entrance to the site was thick with mud and there was no evidence of any operatives taking any action to actively remediate the situation. According to condition 1.1.1 of the permit which states "The operator shall manage and operate activities: a) in accordance with a written management system.....". This condition refers to the EMS which also states the operator must "prevent the escape of waste".

You must ensure that mud and dirt is not tracked onto the highway by vehicles entering and exiting the site. You should ensure that any dirt which does make it's way onto the highway should be remediated immediately.
