This visit was prompted by an anonymous complaint that BAE were allowing TNT to enter surface water. The complaint was taken on 6th February 2017 and was recorded on the Wales incident recording system as number 1700599.

The effluent treatment plant (ETP) discharge is regulated under Consents to Discharge AN0012401 01 and AN0012401 02. It could also come under COMAH jurisdiction as it may have the potential to cause a MATTE, should there be a catastrophic failure.

We were given a comprehensive tour of the ETP, its discharge points and the Berthin Brook. There was no discernible evidence of residues in the stream. The ETP seemed to be working normally.

Analysis results and discharge volumes were discussed, but these are outside the remit of the PPC team and will not be discussed here.

There is no need for further PPC involvement; the necessary work with BAE will be done by Sue Lenthall, Natural Resource Management, Usk.
