Forms A-8, Performance 1, Energy 1, Water Usage 1 and Waste 1 for 2017 were received on 9th February 2018.

The Annual Improvement Targets Summary Report for 2017 was received on 9th February 2018. All the reports are accepted.

Form A-8, Emissions to Air, 8th - 9th November 2017

The annual emissions testing for release points A1 and A2 was carried out in November 2017. The boilers were running at 90 - 100% loading. All NO₂ emissions were less than their emission limit values.

Production

The amount of steam generated was about 1% less than in 2016.

Energy Usage 2017

Total energy used was nearly 5% less than in 2016. However, electricity, oil and diesel usage all increased, while gas usage fell slightly.

Water Usage 2017

Overall water use increased by 15%, mainly due to a water leak.

Waste 2017

Due to a routine maintenance operation, the amount of waste generated in 2017 was considerably more than in 2016.

Performance Indicators 2017

Total energy used per unit of production was almost 4% less than in 2016, but electric was 16% more, oil was 78% more and diesel 38% more per unit of production than in 2016. Gas used per unit of production was 4% less.

Water use rose by 16% per unit of production in 2017.

Comparing waste generation in 2017 with that generated in 2016 is not valid due to the effects of the periodic maintenance operation carried out in 2017.

Annual Improvements Summary Report 2017

There is a remarkable similarity between the report submitted in 2017 and that submitted in 2018. In both years the target for reducing gas, electric and water consumption was 3%, which was not achieved in either year. It appears that a water leak that occurred in December 2016 was not fully repaired until May 2017.

This report does not mention any targets in relation to waste generation.

It is disappointing to see that the targets for reducing gas and water consumption in 2018 are higher than in 2017, however, if these were related to production hours they may show an overall reduction year on year. Though not stated, it would seem as though some of the consumption rates given in these reports relate to the whole site, in which case it would be more meaningful to express them in terms of annual production hours.
