Unannounced site inspection to assess off-site odour in response to complaints and progress with improvements on site.

Non Compliances.

Requirements:

Permit Condition 2.9.1 states that the limits for leachate listed in Schedule 4 table S4.1 shall not be exceeded.

Permit Condition 3.3.1 states that fugitive emissions of substances (excluding odour, noise and vibration) shall not cause pollution. The operator shall be taken to have breached this condition where appropriate measures have been taken to prevent, or where that is not practicable, minimise, those emissions.

Permit Condition 3.4.1 states emissions from the activities shall be free from odour at levels likely to cause annoyance outside the site, as perceived by an authorised officer of the Agency, unless the operator has used appropriate measures to prevent or where that is not practicable to minimise those emissions.

Findings:

B1 - Engineering for prevention and control of emissions.

The Operational cell 9D(ii) still had visible leachate levels in excess of the 1m head as required by the permit. A large area of pooled leachate was visible, which had litter floating on top of it. The enforcement notice served on the 03/03/16 required all leachate head(s) to be back within compliance by the 18/04/16.

This has been scored a **Category 2** breach of permit requirements.

E2 - Emissions, Land and Groundwater.

Leachate was visibly discharging down the haul road into two temporary sumps that had been excavated at the entrance to Cell 9D(ii). From the sump on the left hand side of the haul road leachate was over topping and discharging towards the materials recycling facility. Although the levels of leachate appears to have improved from the last visit material was still escaping the engineered containment.

This has been scored a **Category 2** breach of permit requirements.

F2 - Amenity Odour.

Strong off-site odour of landfill gas was perceivable to the west of the site at levels likely to cause annoyance. The operational cells 9D(i) and 9D(ii) do not benefit from sufficient landfill gas collection and control infrastructure to prevent or control emissions.

Due to the ongoing impact of odour from the site on local residents this has also been scored a **Category 2** breach of permit requirements.
