### 23 & 24 February 2016.

Further site inspection to assess action(s) taken following the pollution incident to the Nant-y-Bradnant. Off-site surface and groundwater discharges appeared to be clean, although sewage fungus was clearly visible around both discharge points.

### Non Compliances.

#### Requirements:

**Permit Condition 2.9.1** states that the limits for leachate listed in Schedule 4 table S4.1 shall not be exceeded.

**Permit Condition 3.1.1** states that there shall be no point source emission to water, air or land except from the sources and emission points listed in schedule 4 tables S4.2, S4.3 and S4.4

**Permit Condition 3.3.1** states that fugitive emissions of substances (excluding odour, noise and vibration) shall not cause pollution. The operator shall be taken to have breached this condition where appropriate measures have been taken to prevent, or where that is not practicable, minimise, those emissions.

#### Findings:

Analysis of the sample obtained from the groundwater discharge point headwall on 23/02/16 returned results of 4.11mg/l Ammonia verses the permitted discharge limit of 0.25mg/l to surface water. This demonstrates that the discharge was still partially contaminated following the pollution incident and the remedial works carried out.

On site the operational cell 9D(ii) was noted as being severely in breach of the 1m leachate head above base stated in the permit, with leachate levels being higher than the previous site visit. Leachate was visible over extensive areas of the waste surface and also escaping the engineered containment. This leachate was discharging across the haul road and unmade ground before flowing into the MRF on site. The depth of leachate accumulated inside the MRF was assessed to be at least 1m in depth.

The breach of the permitted leachate levels and lack of appropriate measures to ensure leachate remains contained in the engineered landfill cell(s) has been scored two **Category 2 CCS breaches** respectively.

Having unpermitted discharge(s) to the receiving surface water has been scored a **CCS Category 3 breach** of permit requirements.
