This was a routine pre-arranged site inspection.

Upon arrival the inspection officer met with Kerry Williams (now of Alun Griffiths (Contractors) Ltd), the site contact. Kerry has overseen operations at the site for period of time and is aware of how the site operates.

Recently the permit operator Dawnus Construction Holdings Limited has entered administration and administrators have been appointed to oversee the process. Natural Resources Wales were made aware of this via the site's Technically Competent Person all in good time. As the company has not yet been dissolved the permit remains in place and compliance with all permit conditions is still required. The Natural Resources Wales Regulatory Guidance Note No 10 provides further information on the status of the permit whilst the permit holder is in administration.

Kerry Williams discussed what the coming weeks may entail and how the permit will be impacted by this. Advice was provided to Kerry Williams on the permit transfer process should this be followed through.

At the time of the inspection, no operations were taking place. Nobody was present on site apart from the regulating officer and Kerry Williams. Kerry Williams explained what usual operations take place on the site including how waste is received, stored, treated and removed from the site. A stockpile of inert waste remains in the central area of this site. This was not causing any issues and was neatly stacked.

No issues or non-compliances were noted whilst carrying out the inspection. It was advised that a site identification board should be placed in a prominent position at the site entrance displaying important information in the event of an emergency. This could include but not be limited to

Site name and address, Permit holder details, Permit number, Emergency contact details, statement that the site is regulated by Natural Resources Wales and Natural Resources Wales emergency contact number 0300 065 3000.

Further advice and guidance will also be provided with regards to transferring the permit.

Please keep the regulating officer aware and up to date with any developments concerning the permit or permitted activities.
