This site inspection was carried out on Wednesday 08 May 2019 by Natural Resources Wales officers Ross Briscoe (Senior Environment Officer) and Julie Hughes (Environment Officer).

Present was Lee Jones and Sonia Jones of Worldcare Recycling Limited and Clare Walters of Ceri Environmental Consulting.

Prior to the inspection being carried out on this permitted area which is operated by Worldcare Recycling Limited, officers had inspected the neighbouring site which is operated by World Care (Wales) Limited – the sites are adjoining.

The visit consisted of an inspection of the permitted area, however site documentation had been reviewed within the main site office prior to carrying out an inspection at the neighbouring site operated by World Care (Wales) Limited. This documentation showed that staff training had been carried out and documentation and procedures had been reviewed and implemented since the previous inspection (27.03.2019).

Weather conditions throughout the inspection were overcast with damp conditions underfoot.

Although open, no waste activities (apart from waste storage) were taking place on the site whilst officers were present.

Since the previous inspection the quality of waste on site had significantly reduced. The site was much tidier and better organised. Skips containing exempt waste had also been repositioned and areas of open space was available for the storage of machinery.

Only permitted wastes were observed on site.

The hardstanding areas of the site were in better condition with no large pools of standing water or rutting of the surfaces noted. The highway outside the site was also clear of mud/debris and appeared to have been recently swept by cleaning equipment.

All outstanding waste returns have also been received by Natural Resources Wales.
