Purpose of Compliance Assessment

This inspection was an Operator Monitoring Assessment for emissions to air. A water OMA is written up separately.

Refer to the OMA check sheets and documentary evidence attached.

A score of 83% was given.

Most of the monitoring is covered by the MCerts scheme: methods, lab analysis, stack monitoring, certified instruments. Calibration, maintenance and traceability of reference gases has also been covered.

The operator needs to include the air emissions monitoring more fully within the control of their EMS, from the point of view of: scheduling, data validation, understanding monitoring, reviewing monitoring, training and auditing.
