4. Details of our assessment

Three local residents (members of the Hafod community liaison group) were present during this site inspection so that they could become familiar with recent developments at the site including capping works, new gas wells and the construction of the new cell (5a), before the Hafod community liaison group meeting later that evening.

The last loads of waste were tipped while we were on site and site operatives applied daily cover.

There was no odour detected on site during the inspection.
