### 4. Details of our assessment

The Head of North East Wales Operations for Natural Resources Wales (NRW) accompanied officers during the inspection to gain an overview of recent developments at the site including capping works, installation of new gas wells and construction of the new

cell (5a).

There was a very slight landfill gas odour detected on site. This odour was short lived (less than a minute) and localised (western bund). This odour could not be detected during an offsite odour assessment completed immediately after the site inspection. This offsite odour assessment included the following areas: Newhall Road, Vauxhall industrial estate, Heol estate and Bangor Road.

There was a large number of seagulls observed on site. The operator explained that they currently use an operative with a hawk to manage the seagulls, but they are looking into applying to NRW for a culling licence given the large number of birds.

The large number of seagulls was not observed offsite during the offsite odour inspection in the areas described above.
