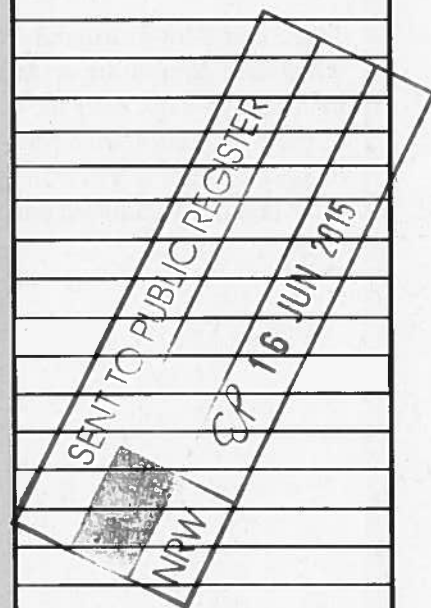

Following a visit in March, Dragon were asked to improve drainage on the unmade ground that had been used to store processed material awaiting re-use or recycling. Trenches have been dug throughout the area, connecting to another around the perimeter of the site which discharges to a soakaway. The trenches are 18 to 24 inches deep and contain plastic perforated field drain pipes, lined and backfilled with pea gravel and chippings. Hydrogeology specialists at Natural Resources Wales will be consulted to check that these arrangements are satisfactory, but at the moment this seems an adequate solution to the problem.

Action from 25th March 2015: Dragon to send completion dates for the proposed drainage works to NRW *by 1st May 2015*. This action is complete, the drainage works have been installed and the work is finished.

Business matters were discussed. Mercury recycling volumes are likely to be similar to those in 2014. Dragon will be installing equipment to scan the meters as they are received because their customers want traceability from "cradle to grave".

There was a lot of litter and a small amount of fly-tipped floor tiles outside the site perimeter, some of which had come from an adjacent site's skips. These had lids but were open, allowing paper and light materials to blow over the adjoining ground. The company, Richards and Appleby, were visited and two of the managers (Brian Mahoney, Production and David Meredith, Operations) were asked to collect and dispose of their litter, with help from Dragon. They confirmed, by telephone on 26th May 2015, that the litter had been removed and were thanked for their co-operation.
