The manufacture of mercury sulphide (HgS) is proving more difficult than at first thought. There are several machines on the market claiming to be capable of making the compound, but on further investigation it appears that none can actually be used reliably yet. Dragon have therefore entered into a joint development project with an academic institution to try to solve the problem. Natural Resources Wales (NRW) have been invited to attend a meeting to discuss possible manufacturing methods. An alternative use for the recovered mercury has been found, so the urgency of finding a reliable HgS production method has reduced slightly.

Dragon are maintaining their contacts with Veolia in order to keep all their options open.

Dragon are bidding to renew the contract for reclaiming the mercury for the next five years. The result should be known shortly.

The site was inspected and the carpet for recycling that had been stored outside has been sent for processing. This has revealed a lot of unmade ground which is wet and muddy and not acceptable in its present state. Dragon plan to put down aggregate with tarmac "runways" in between to allow access for forklift trucks. A surface water drain will be laid around the site perimeter to collect run-off from the hardstandings. This water will be collected in an interceptor and then discharged to sewer.

Action: Dragon to send completion dates for the proposed drainage works to NRW **by 1st May 2015**.
