The main purpose of this visit was to confirm that Environment Agency (EA) hard hats sent to Dragon for recycling were not identifiable as having belonged to the EA once they were shredded. The hats are shredded into small chunks, sold on, pelletised and used to manufacture, amongst other things, electrical fittings. Nothing identifiable could be seen in the shredded hats.

The site was inspected and found to be clean and tidy. The large amount of "dumpy" bags stored outside on unmade ground have been moved and this area now only contains a few wooden pallets and a lot of plastic pallets. There are plans to lay concrete on part of this area.

Very little mercury is being recycled at the moment.

Dragon are renting an adjacent building for meter storage and there are other plans, currently under negotiation, for the site.
