This was a routine unannounced inspection conducted by Environment Officer (EO) Paul Challender. During the inspection the weather was mild and overcast after a period of several days of heavy rain. During the inspection EO Challender was accompanied by Gabrielle Povey of Flintshire County Council.

Prior to entering site the rear, northern and front fence were walked. The litter situation which, was noted to have vastly improved during the last inspection and has been maintained. It is good to see the installed netting to mitigate against this is still performing its task well.



The Site Diary was assessed and was up to date with pertinent information.

On commencing the inspection the site was undergoing a test of a new potential new vehicle to mitigate against noise issues during the deposit of separately collected glass recyclate. After this test the site resumed normal operation.

No issues were noted on site save for windblown litter laying between the rear fence and waste transfer building. It was stated that this litter is collected during weekly periods of maintenance. As this litter is not emanating from the permitted area and is subject to a clean down procedure no score has been given on this occasion but this will be monitored in future inspections.



Post inspection the Waste Returns for Q1 were assessed and no issues were identified.
