Reporting of Continuously Monitored Emissions to Air for sulphur dioxide for the month ofOctober....., 2014



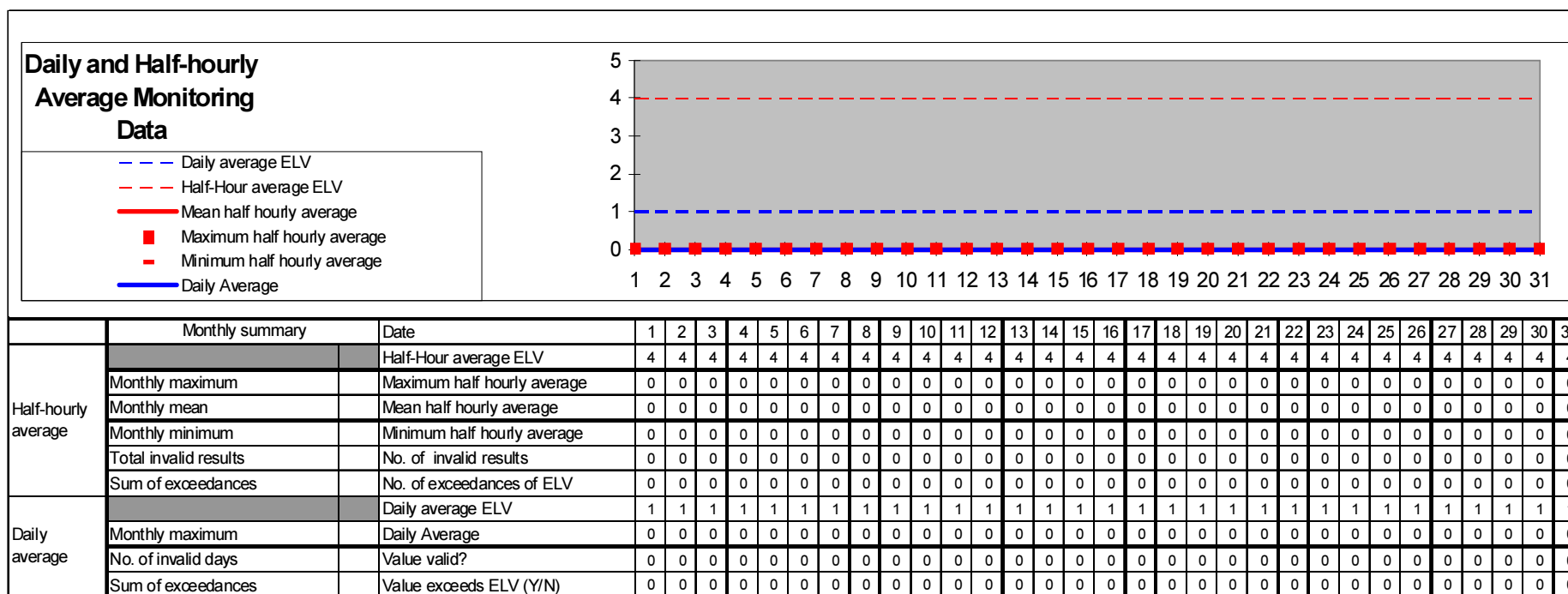

Reporting of Continuously Monitored Emissions to Air for hydrogen fluoride for the month ofOctober....., 2014



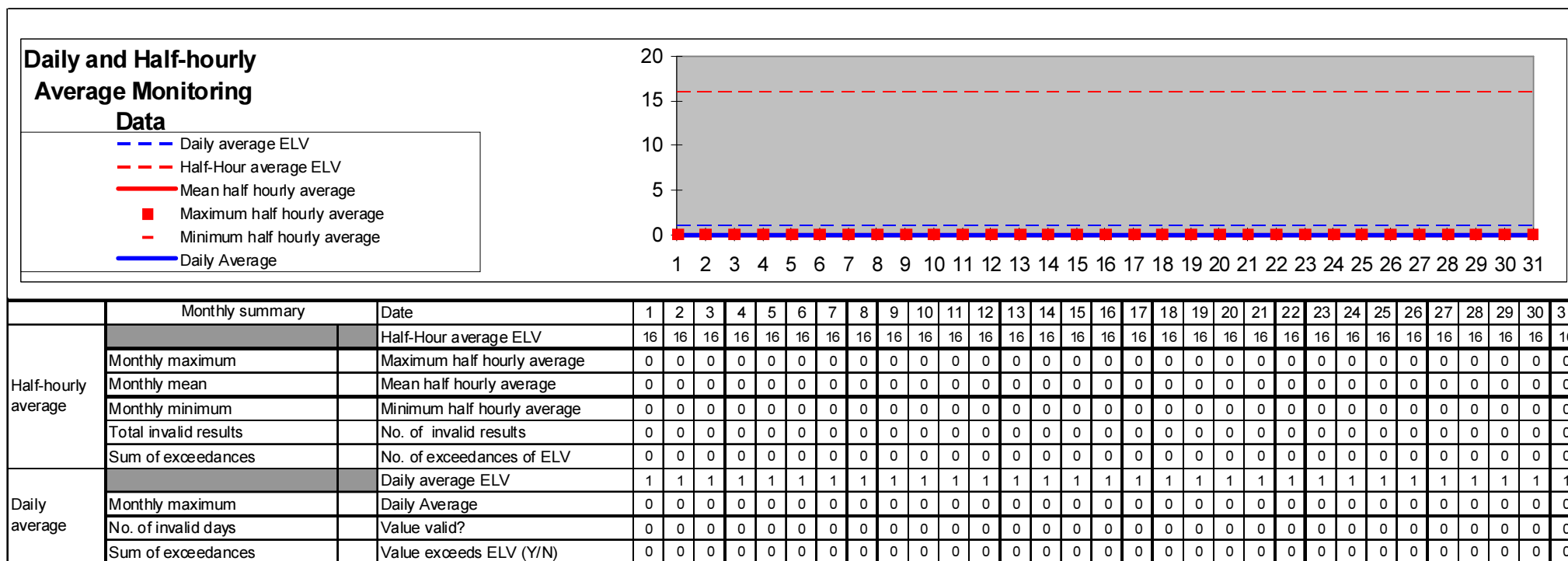
