This was a routine unannounced inspection by Environment Officer (EO) Paul Challender. During the inspection the weather was warm and overcast after a period of several days of heavy rain.



Despite the recent heavy rain the hardstanding surface was in good order with only minor pooling of water. On arrival at the waste operation waste soils were being deposited and treated by site operatives. Bays and stockpiles of waste, post-treatment waste derived products and bought in product were clearly segregated and stored in compliance with storage conditions of the permit.



In the office a selection of paperwork and documentation was reviewed including Waste Transfer Notes (WTNs) for waste leaving the operational site, Site Diary, Permit etc..... Discussions were held concerning Technically Competent Manager (TCM) cover and training of additional TCMs. TCM cover at present is sufficient and keeping the site in good order. The Site Diary was up to date and utilised to record pertinent information, the witnessed WTNs had been populated with all necessary information and the Permit and Environmental Management System were readily accessible to staff.

The new office area is now complete and there may be some further development at the entrance to the permitted area in the near future. The recent developments do not affect the permitted waste operation and the potential new alterations as discussed during the inspection (eg: installation of a barrier) should cause not conflict with the permit conditions.

Advice and guidance was given on the submission of waste returns. To reiterate please ensure that the quarantine skips both general and metal in addition to the unprocessed waste (clay) soils are fully reported in submitted Waste Returns for the quarter that are transferred to another waste operator.
