## 4. Details of our assessment

This was an unannounced site inspection.

The weighbridge was closed, vehicles had stopped tipping and daily cover had been applied over the tipping area.

While it was evident that daily cover had been applied over the tipping area, some areas e.g. either side of the vehicle track leading up the western flank, eastern edge of the tipping area, would benefit from a more even distribution of material being placed as patches of waste were visible. This was discussed with the Area Manager following the inspection. NRW considers this a breach of permit condition 1.1.1 (C2-CCS3).

Action 1: At the end of the working day, ensure staff apply a sufficient amount of daily covering material to the tipping area in line with the Environmental Management System (EMS) and operational procedures (SHE-OP-13-The use of daily cover material).

There was no odour observed on site during the inspection. Similarly, there was no odour detected during an offsite odour assessment completed immediately afterwards. The offsite odour assessment included the following areas: New Hall Road, Vauxhall industrial estate, Heol estate and Bangor Road.
