Natural Resources Wales e-mailed DCWW on 27/09/2021 to highlight that no iron data had been received for this works for 2021 up to 27/09/2021. As a result, iron data was submitted to NRW on 11/11/2021. Seven results were submitted for the period of January to July 2021. Being late these results count as non-compliances.

Our enforcement response is subject to further investigation.
