Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

A routine check of spreading notifications required to be submitted under the permit EPR/KP3594VE held by Trade Effluent Services was carried out. During this check it was identified that spreading dates were not in compliance with those agreed at application for deployments PAN-012768 & PAN 013348. Condition 2.1.5 of the permit states; The

activities shall only be carried out in accordance with the requirements of the agreed deployment form unless otherwise agreed in writing by Natural Resources Wales
The applications/deployment forms for the above deployments stated the following;

PAN-012768 'It is intended to spread the wastes to arable fields before seedbed preparation. For this application, the wastes are expected to be applied to all fields in February/March 2021.'

PAN – 013348 'It is intended to spread the wastes to arable fields before seedbed preparation. For this application, the wastes are expected to be applied to all fields in March/April 2021 and to the grass fields in June/July 2021.'

Spreading notifications were received for both deployments for the period 06/11/2021 – 19/11/2021.

During the application for a deployment spreading times are used to assess the agricultural benefit of the spreading activity. Information on when in the crop cycle the waste is planned to be spread forms an important part of the determination and therefore in ensuring the activity is not a disposal activity. Spreading taking place where there is no agricultural benefit is deemed a disposal activity.

Condition 2.1.5; Category 3 Non-compliance score.

Spreading not in compliance with the agreed deployment form poses a risk to the environment through an increased risk of nutrient run-off, which has the potential to impact on the water quality of local watercourses. Although the waste type had been agreed for the above deployments, this was based on spreading taking place during the growing season as stated at application when there was a crop need. This breach has therefore been given a category 3 Non-Compliance score.
