A compliant inspection. We do however have a few minor issues which will need to be resolved:

1. As discussed on site, storage silos for feed should be protected from collision damage. It was agreed on site those silos that needed addressing and most vulnerable. Barrier systems similar to those around the gas tanks were the preferred option, however if you have any other ideas or intentions please let me know. Please could you send photographs of the barriers on completion of the works.

2. As leaving the site we became aware that the Natural Resources Wales incident line was incorrect on the notice in the gatehouse. Please could this be updated on the notice and other relevant documents (e.g accident management plan, emergency contacts etc.) to the new number: **0300 065 3000**. Could this be done as a matter of urgency.
