Quarterly Environmental Monitoring Report (1st August to 31st October 2018)

We have reviewed the above report submitted with regard to Permit Condition 4.2.2.

Perimeter Landfill Gas Monitoring

During this reporting period there were no readings in excess of the compliance level for methane.

Groundwater Quality

There does not appear to be any groundwater quality data included in the report for boreholes GW1, GW2, GWBH06R, GWBH26 or GWBH34, which are required by Table S4.10.

Action 1: Provide an explanation for the above omission to NRW, by 31.01.2019.

The Permit limit for Mercury (0.01 ug/l) appears to have been exceeded in GWBH04 on the 25/10/2018 at 0.00002 mg/l (0.02 ug/l), i.e. twice the permitted limit.

This breach has been scored a CCS Category 3 breach of Permit.

Action 2: Investigate this breach and report back to NRW, by 31.01.2019.

In some case the detection limits for Mercury, Tributyl Tin and Trifluralin appear to be above the respective Permit limits, as given in Table S4.4.

Action 3: Investigate the above and report back to NRW, by 31.01.2019.

Surface Water Discharge Quality

The Permit limit for pH (<6 and >9) appears to have been slightly exceeded at W1 on the 12/09/2018 at 9.2.

This breach has been scored a CCS Category 4 breach of Permit.

Action 4: Investigate this breach and report back to NRW, by 31.01.2019.

Leachate Levels

There were no breaches of permitted leachate levels throughout the review period.

In Waste Gas Quality

Of the 777 gas well readings there were no readings of carbon monoxide in excess of 100 ppm.

Ambient Air Monitoring

Concentrations above 1000 ppm were noted, but at no location were there 3 consecutive breaches.
