During the inspection of 17th October 2014 Poeton were asked to take remedial action to remove and prevent water collecting on the anodising shop floor and to present a plan of action to deal with the problem to Natural Resources Wales (NRW) by 3rd November 2014. The plan was received by email on 7th November 2014.

This was four days later than agreed and Poeton are reminded that all submissions should be received by NRW on or before the due date, otherwise a non-compliance will be issued.

The plan was to skim the floor with concrete and then apply a two part epoxy paint. This is an interim measure as the anodising shop will be moved once the new extension is complete. A completion date of 28th November 2014 was agreed. Photographs of the repaired floor were received by NRW on 24th November 2014.

The photographs show that the floor has been repaired to a good standard in a timely manner.

This action is complete.
